- You have a basement with a pumping facility that discharges to the sewer main at or below an elevation described above.

- All water connections are subject to inspection by the Health Dept for which there is a permit fee, payable at the Nelson County Health Dept, 325 S Third Street.
- All fees are to be paid before any connection will be made.
- Contact the Bardstown Sewer Department for inspection of the sewer tap prior to any cut or connection being made to the public main.
- A two (2) week notice is required for all connections.
- The owner and building contractor shall assure that the meter is set at grade and not damaged at the time of final grading. The City will charge for any necessary repairs or changes to the initial installation.
